

Operation's Managers Report

Like most sectors of Aotearoa's economy, the environmental sector has not escaped the economic slowdown and the negative effects of escalating project costs. During these challenging times I'm extremely grateful to work alongside a stable and committed Executive Committee dedicated to delivering meaningful outcomes for our project partners, communities and waterways. A huge thankyou to the Executive Committee for all their support over this last year from both Mandy and me.

At RiverCare our mahi is all about working with our communities throughout the Waikato River catchment. Leading our mahi with mana whenua in the Taupiri-Huntly-Te Kauwhata rohe was our koro Pat Kingi; his passing this March touched many of us at RiverCare. He leaves behind a legacy of native plantings at projects like Lake Whangape, Lake Waikare and Lake Kopuera.

Mandy and I, alongside our project partners and supporters enjoyed two excellent community planting events this planting season. One event at Huntly with Genesis Energy and a second event at the Barbour Farm in Waotu. Our teams of volunteers successfully planted more than 9,000 plants across the two projects and it's great to see so many people keen to get stuck-in and enjoy a day out on the farms.

Although RiverCare's 2024 planting season delivered some excellent project results, plant numbers were down significantly on previous planting years due to the impact of tough economic conditions. This trend is expected to continue into 2025-26 planting season with hopes for a recovery in plant numbers thereafter. A total of 52,125 native plants were planted across 12 different projects. I've previously talked about 'Climate resilience' and this summer has been another of those long dry summers we all love for the school holidays.

Operation Manager's Report continued

Unfortunately, we are now seeing some plant losses at projects as the dry weather continues well into autumn; current project losses are still at manageable levels, but some rain would be great. RiverCare is working with a project partner to develop a practical and affordable solution for planting sites evaluated as 'high risk' due to extremes in environmental conditions. Several key learnings have already been made and solutions applied with promising results. Highlights and key milestones over the last 12 months include:

- RiverCare successfully completed several long-term projects including, Genesis Lake Whangape project 22,700 plants, Lake Ohinewai Recreational Reserve 18,605 plants, Opuatia catchment 26,282, Smythe Farm project 23,500 plants and Wai 0 te Atua Stream project 25,200 plants.
- RiverCare completed our first project with Tainui Group Holdings, the site at Meremere involved the planting of 3,500 grasses and rushes to enhance land drainage corridors.
- Our MOU has been signed between the three parties and a project plan developed to guide delivery of this exciting initiative over the next 2 years.

- RiverCare has two new wetland projects in the Mangawara catchment aiming to plant 24,205 plants over the next five years, these new projects complement several projects RiverCare has undertaken in this significant catchment
- RiverCare was successful in securing new project funding from the WRA for the Mangawara Catchment LWM6/12 Tree Stand Restoration Project - \$31,988.00 and Hampton Downs Simmental: Wetland and Tree Stand Restoration Project - \$78,600.00.

Over the next twelve months I look forward to advancing RiverCare's project with POU Ltd in partnership with our network of contractors, project co-funders and supportive project partners to deliver this exciting initiative.

RiverCare's Performance Review

Waikato RiverCare Incorporated has been compliant with the objects and rules listed in its revised Constitution (2024):

The Society was established for environmental and charitable purposes within New Zealand only.

- (a) **Core activities** The enhancement of the natural water and riverside environment of the Waikato River and associated catchments to improve habitats and thereby benefit the users of the river and its environs, local communities and visitors, now and for future generations through:
 - (i) Providing improved plant and animal habitat in and around the Waikato River and associated catchments for general ecological benefit.
 - (ii) Promoting public interest and appreciation of the Waikato River and associated catchments and its environs through education and communication with local communities and other river users for the benefit of achieving awareness and support for the need to maintain and enhance the riverline environment.
- (b) **Funding** to raise, accept, accumulate and employ funds for the environmenal and charitable purposes authorised by these objects.
- (c) **General** to do all such things as are conducive or incidental to the attainment of the environmental and charitable purposes authorised by these objects.

Performance Measures

Performance is measured through project evaluations which monitor planting health, establishment, pest plant prevalence, fence condition and stock exclusion. The use of several photo points helps illustrate planting success and condition, and assist in identifying long term management considerations.

Project progression from active management to receiving pulse maintenance after five years is the underlying measure of project success for Waikato RiverCare.

Performance in Relation to the Strategic Business Plan

Waikato RiverCare has persistently sought out and cultivated new project opportunities within the Waikato catchment, concentrating on upper catchments, constructed wetlands, critical habitat projects, and prioritized areas for our project partners. This strategy has played a crucial role in the organization's success in obtaining new funding for various projects.
