The Waikato River is a national and regional icon holding significant cultural, economic, social and environmental values. The Lower Waikato River Enhancement Society Inc (LWRES, trading as 'Waikato RiverCare') links these values with interested organisations and provides a vehicle for riparian habitat restoration using a base of native plant species. Waikato RiverCare was incorporated in 2001 and is supported by a range of community stakeholders with a common vision and purpose.

The geographic area covered is over 120 kilometres of river (and associated banks) along the Waikato River downstream of Hamilton City to the river mouth at Port Waikato.

Introduction

Waikato RiverCare is pleased to present our Annual Report for the 2012/13 period. The report documents achievements in relation to established projects and new projects initiated in this period. It also provides the mandatory Chairperson's Report and Annual Financial Statement.

Waikato RiverCare has been operating since 1999 and officially became an incorporated society in 2001. Members include a range of organisations and people who all share a similar passion for the lower Waikato River.

Waikato RiverCare is the leading riparian restoration charity focussing on preparing, planting and maintaining areas of native plant habitat on the banks of the lower Waikato River, and sourcing funds and support to carry out this work. Sound science, cultural understanding, sustainability and a cooperative approach is an important part of the group's focus.



Structure of Waikato RiverCare

The organisation is governed by an Executive Committee whose membership comprises one representative from each foundation member organisation. In addition, up to three general members can also be appointed to the committee. An advisory group is being set up to offer high level support and political advocacy.

Most of our new members have found the time to take up the mantle and become actively involved in the development of Waikato RiverCare. This enterprising spirit has allowed us to set up dedicated project teams to look at a variety of Waikato RiverCare work streams.

In governance development we have established an advisory membership, and are happy to announce Peter Buckley, Chairman of Waikato Regional Council and crown appointee on the Waikato River Authority board, as our first advisory member. The advisory members offer higher level guidance and political support to Waikato RiverCare. This year Waikato RiverCare has already undertaken a full assessment of all our existing project sites, developed a detailed forward plan and budget, made new friends and helped to advise stakeholders and landowners on environmental policy.

A major new \$600,000 programme of works has been started in association with our major sponsors and the Waikato River Authority, looking at building the capacity of Waikato RiverCare, developing a riparian restoration guideline, working with stakeholders and of course our main focus, creating corridors of native vegetation along the riverbanks.

Operation Manager's Report Kevin Hutchinson

It has been an incredibly busy 5 months since joining the Waikato RiverCare team in mid-October, 2012.

As with all organisations linked to the land, the first three months of 2013 can be summed up as being 'extremely challenging', witheven the wettest and most established planting projects showing stress as the region wide drought continued. Although some sites appear to have suffered terrible losses in late February / early March I'm hopeful that some plants will recover when autumn rains return.

To pre-empt significant plant losses in the future during drought conditions Waikato RiverCare has chosen to invest in mobile irrigation, purchasing a pump and hose now stored at the Regional Council depot in Gordonton.

The excellent weather conditions this summer has allowed contractors to complete identified weed control, including Ecoarb undertaking tree removal at several sites and Treescape (Waikato and Central North Island) successfully completing all required foliage spraying.

Several key documents and policies have been developed over the last 5 months including a Standard Operating Procedure, Hazard Identification and Management Plan, Project Exit Strategy, Updated Fencing Strategy, Updated Waikato RiverCare's Project Checklist (minimum 10m planting zone above 'mean high water'), and Proposed Future RiverCare Projects.

At the end of last year Waikato RiverCare started work on the Riparian Restoration Guideline with the production of a specification which was sent out to a selection of professional environmental consultants. Three proposals were received from four leading independent consultants, with Wildlands Consultants Ltd chosen as the successful contractor. Over the next three months Waikato RiverCare and its partners will support WildlandsConsultants in the production of the guideline document, a key component of the Waikato River Authority funding.

This coming autumn marks the start of significant in-fill planting in May to make the most of summer weed control and replenish sites hit by the drought. 6,000 plants have been ordered for planting at four projects

which are planned to be completed prior to the arrival of winter flooding. Work is also expected to start on erosion control at identified sites in conjunction with Waikato Regional Council's River and Catchment Services.

It is an exciting time for Waikato RiverCare with the announcement of our first Waikato River Authority funded project, RaahuiPookeka A. Site planting is expected to startin September/October this year on the 1100m project.

Other coming highlights include the identification of the second Waikato River Authority project, the development of project signage/promotion and work starting on the Hakarimata A extension project. There is also an opportunity to work with those planning and implementing planting on NZTA roadside/river areas near the Rangiriri Bridge.

Future Plans

Waikato RiverCare is ensuring financial sustainability by looking at budgets moving forward on a 5-year cycle and planning for the future through an on-going sponsorship. The generous support of our major sponsors: Waikato River Authority, Mighty River Power, Genesis Energy, Waikato Regional Council, Watercare and the Waikato Catchment Ecological Enhancement Trust have made it possible to plan more efficiently into the foreseeable future. Waikato RiverCare is always looking at opportunities to establish relationships with organisations that have synergies with Waikato RiverCare's leadership role in riparian restoration, and is in the process of seeking additional sponsorship opportunities.

It is Waikato RiverCare's objective to plant up to two hectares of riverbank per year (or two kilometres based on a ten-metre wide riparian margin). Quality of planting is paramount, so Waikato RiverCare is concerned with good preparation of the sites, the application of sound science, sustainability, eco-sourcing and creating corridors of continuous native habitat.

Education and collaboration are key to ensure the best possible environmental enhancement of the lower Waikato River. It is for this reason that Waikato RiverCare spends time and effort to try to recreate native ecosystems, to get everything right and share this knowledge with our partners.

Each site has an average 5 year cycle from inception to being returned back to the landowner as a native habitat. With each site, there is an approach of undertaking the project in distinct phases:

Indicative costs will vary from site to site depending on the amount of preparation required and social and stakeholder involvement.

Every yearthe typical workload of Waikato RiverCare involves:

- two sites being initiated in preparation phase
- two sites being planted in planting phase; and
- six sites being maintained in maintenance phase
- an increasing number of sites completed.

Site Progress and Achievements

During the 2012/13 planting season, Waikato RiverCare actively engaged around 40 volunteers for some of the planting and maintenance work on sites. In total, 5375 native plants have gone into the ground at four riverbank locations between Ngaruawahia and Pokeno.The table below shows what phase of management each of Waikato RiverCare's sites were in this year and will be in for the coming year.

Sites Update - Current Sites

1. Ngaruawahia Waikato Esplanade

Previously reported as two planting sites, the Upper and Lower Waikato Esplanade reserves, Waikato RiverCare has suspended planting effort at the Upper esplanade reserve indefinitely. A review completed and presented to Committee concluded poor long-term prognosis for the site due to topography and green waste dumping, and recommended a withdrawal of effort and focus on the Lower Esplanade Reserve.

In December 2012 1,000 flax (*Phormiumtenax*)were planted by Waterside Planters Ltd between the boat ramp and road-bridge at Turangawaewaemarae in Ngaruawahia, which have done extremely well even through the drought conditions experienced this summer.

Maintenance weed control was completed by Treescape and weed tree removal completed by Ecoarb.

This autumn work will focus on completing planting at this site and maintaining weed control with the existing planting area.

The dumping of green waste from adjoining properties continues to be an on-going challenge for Waikato RiverCare in this area, with Waikato Rivercare's Committee endorsing a management approach fostering greater collaboration with Waikato District Council to raise awareness within the community around green waste dumping. A signage campaign, in association with local schools, has been put in place to enhance public awareness of the issue.

2. Hakarimata A

Hakarimata A is now a well established planting with good canopy cover throughout its length. Work at this site is now largely focused on maintenance weed control.

Both Treescape and Ecoarb contractors spent time working at Hakarimata A, controlling a number of weed species. This planting site has Waikato RiverCare's only known Tutsan (*Hypericumandrosaemum*)infestation which is limited to an area which received erosion protection.

The extension of this planting project in the 2013-14 financial yeardownstream into the Department of Conservation managed Marginal Strip Reserve is a fantastic opportunity for Waikato RiverCare, and adds an additional 350m of riverbank planting to the project.



Hakarimata A

3. Hakarimata B

Hakarimata B is now awell established planting with good canopy cover throughout its length. Work at this site is now largely focused on weed control of Woolly Nightshade (*Solanummauritianum*) and Japanese Honey Suckle (*Lonicera japonica*) and maintenance. The close proximity of Hakarimata Road and a blind corner at the northern end of this planting has made working at this site challenging.

Future work at Hakarimata B will be maintenance focused with the long-term goal of site management returning to the Waikato District Council.

4. Taupiri A

Planted in 2009 the Taupiri A site has developed well despite being a difficult site. Recent work at the site has focused on weed maintenance and infill planting round the boat ramp. The inability of sedges to prevent weed species from establishing has required further investment in plants that will from a canopy with height while still providing a vista of the river from the car park/boat ramp area.

Weed tree control was completed by Ecoarb in the vicinity of the boat ramp, removing several Alder (*Alnusglutinosa*) trees previously drilled and poisoned.

Infill planting is planned for Autumn 2013.

5. Taupiri B

Planting started at Taupiri B in 2011 and continued in 2012 through the partnership between Waikato RiverCare and the Ngaruawahia Police youth diversion scheme. Scheme participants planted around 300 plus plants on organised monthly planting days.

Although narrow, the site is relatively weedfree and elevated, reducing Yellow Flag Iris (*Iris pseudacorus*) encroachment on the site. Treescape completed maintenance weed control at the site in preparation for infill planting in autumn 2013.

Taupiri B has been identified as a priority project to promote the work of Waikato RiverCare to the general public as there are excellent views over the project area from State Highway One. The development of project signage for this site is well advanced.



Once infill planting in autumn 2013 has been completed the priority for Waikato RiverCare at Taupiri B will be maintaining stock exclusion and maintenance weed control.

6. Taupiri Ki Waenganui

Taupiri Ki Waenganui was identified in 2011 with funding earmarked for fencing and site preparation in 2012. However all works at this site are now on hold due to the property being placed on the market. Once the property is sold Waikato RiverCare will discuss fencing and planting opportunities with the new owners.

Waikato RiverCare remains committed to completing a project at Taupiri Ki Waenganui with the new property owners.

7. Taupiri D

First planted in 2011 with infill planting completed in September 2012 by contractors working for WaahiWhaanui Trust; Taupiri D has suffered some significant plant losses during the drought due to the sandy soils found at this location as well as the short period of time between planting and the effects of the drought.

During routine monitoring of this site in November 2012 a significant infestation of Alligator Weed

(Alternantheraphiloxeroides) was found growing within the planting. Control was completed by Waikato RiverCare staff and Waikato Regional Council contractors over several months with good results. However continued monitoring of this site will be required for the next two years to confirm elimination of this pernicious weed threat.

Infill planting is planned at this site in autumn 2013 to replace lost plants during this year's drought.



Taupiri D

Taupiri D has been identified as a good location to place promotional project

signage given its close proximity to the RaahuiPookeka site, views from State Highway 1 of the plantings and long boundary adjoining the State Highway.

8. TeOhaaki

Te Ohaakiwas first proposedas a project in 2011 but not progressed further. In November 2012 Waikato RiverCare's Operations Manager visited the site, presenting a report to Committee identifying risks and opportunities at this site. The Committee endorsed placing this project on hold until identified issues at the site are addressed.

9. Huntly Golf Course

The 900m long project at the Huntly Golf Course has done well since being planted in 2009. Its location on the Te Araroa trail and easy access from the Huntly Golf Course makes this site one of Waikato RiverCare's priority areas. Weed control completed by Treescape has significantly reduced weed burden at the site this year. Infill planting is planned in autumn 2013, to reduce the spacing between plants in an effort to combat weed reinvasion and take advantage of site weed control completed by Treescape during the Christmas period.

Effort at the Huntly Golf Course site will be focused on: complementing the Waikato Regional Council's work to eliminate Yellow Flag Iris from the lower Waikato River; reducing the prevalence of weed species within the planting zone and increasing Waikato RiverCare's profile with walkers on the Te Araroa trail and the Huntly Golf Course users through signage and web site development.

10. Te Kokiri A

Te Kokiri A has failed to develop with only isolated patches of plantings establishing. A period of prolonged flooding impacted on the new plantings combined with continued stock encroachment and Yellow Flag Iris establishment within the planting site. In addition this site is subject to extensive erosion due to its location on a river bend and sandy soils.

Effort at Te Kokiri A will be focused on complementing the Waikato Regional Council's work to eliminate Yellow Flag Iris from the lower Waikato River, reducing the prevalence of weed species within the planting zone and increasing Waikato RiverCare's profile with neighbouring property owners and Horahoramarae members.

11. TeKokiri B

Te Kokiri B continues to develop well with increasing canopy cover and robustness.

Stock has been observed grazing in the

plantings on several occasions. Follow-up communication with adjoining landowners has reduced the incidence of grazing occurring; however the long term security of Te Kokiri B requires resourcing.

The riverbank stabilisation undertaken at the site by the Waikato Regional Council has worked extremely well arresting the loss of riverbank, continuation of this work downstream into the TeKokiriA site is encouraged by Waikato RiverCare.

Treescape completed maintenance weed control at Te Kokiri B, noting Yellow Flag Iris as the single significant weed threat.

Effort at this site will be focused on complementing the Waikato Regional Council's work to eliminate Yellow Flag Iris from the lower Waikato River and reducing the prevalence of weed species within the planting zone.

Te Kokiri A and B

12. Rangiriri A, B, C

Rangiriri A, B and C collectively form Waikato RiverCare's longest continuous length of riparian planting, with a total length exceeding 3.0km. Topography through this distance varies greatly from flat flood

plain through to steep drop offs down to river level of up to 8m high. A site review undertaken in late 2012 identified several areas of concern for Waikato RiverCare; including the road stability of Churchill East Road in the Rangiriri planting, С the extensive Yellow Flag Iris invasion within the plantings and the narrow width of plantings.

In early 2013 Treescape was

contracted to undertake spraying at all three sites in the first steps to eliminate Yellow Flag Iris from the planting sites. Control of several other key weed species was also undertaken in conjunction with Yellow Flag Iris spraying.

Effort at the Rangiriri sites will be focused on complementing the Waikato Regional Council's work to eliminate Yellow Flag Iris from the lower Waikato River, reducing the prevalence of weed species within the planting zone and building partnership opportunities with NZTA and the Rangiriri community during the construction and realignment of State Highway 1 particularly round the Rangiriri A&B sites.

13. Churchill East Road A (CERA), Churchill East Road B (CERB)

The Churchill East Road A and B sites were first planted in 2009 and 2010 after fencing was completed to exclude stock access to the river.

A site review completed by the operations manager in 2012 identified significant concerns at boththe Churchill East Road A and B sites. The recommendation presented to Committee that all works at these two sites be placed on hold until such time as river bank erosion is addressed, was endorsed byCommittee members. Waikato RiverCare is actively encouraging and supporting the Waikato Regional Council to complete bank stabilisation works at these sites in August/September 2013. When boththe Churchill Road sites are stable Waikato RiverCare is committed to returning to these sites and completing the riparian planting.

14. Meremere

Meremere is one of Waikato RiverCare's firstprojects and our most northern project actively worked on currently. The project is well established and provides Waikato RiverCare and the public with an excellent example of what's possible when starting off a With planting project. plantings nearing 7-8m in height you experience a sense of visiting a lowland forest and not a planting as you walk the trail.



Meremere

The Meremere site's position on the TeAraroa trail provides Waikato RiverCare with an excellent opportunity to raise our profile with visiting hikers as they walk the trail. In addition to this site the trail passes through five more Waikato RiverCare projects.

Its close proximity to State Highway 1 makes it an ideal site to build Waikato RiverCare's profile with passing motorists through the placement of signage.

The position of the Meremere site on a river back-water and the significant weed infestations upstream has led to both Waikato RiverCare and the Waikato Regional Council spending a significant amount of time and resources controlling Yellow Flag Iris and Alligator Weed at this site. In the future this cost should reduce as upstream control programmes reduce weed seed sources.

This year Treescape completed weed maintenance at Meremere, focusing effort on Yellow Flag Iris and Woolly Nightshade. In the coming year some effort will be required on controlling and preventing the spread of Japanese Walnut (*Juglansailantifolia*) though the planting site.

Waikato RiverCarewill continue to complement the Waikato Regional Council's work to eliminate Yellow Flag Iris from the lower Waikato River and reducing the prevalence of weed species within the planting zone at the Meremere site.

Upcoming Sites in 2013/2014

1. Hakarimata A extension and Clearwater licence projects

Both the Hakarimata A extensionand Clearwater licence projects are located on Department of Conservation administered reserves next to existing Waikato RiverCare projects. The HakarimataA extension project adds 318m to the Hakarimata A site and the Clearwater project provides an additional 100m to the Hakarimata B site.

Both sites provide excellent opportunities to build relationships with other land owners and administrators, with the potential to expand into new areas adjoining these sites.

2. Hakarimata C and D projects

The Hakarimata C and D projects are located either side of the one-way bridge located on Hakarimata Road.

These projects have progressed well over the last year, with site planting preparation almost complete. Forest Flora have done an excellent job taking on the weeds found at these two sites and their good work can be viewed from Hakarimata Road as you drive Hakarimata Rd.Planting at the sites is expected to start in September 2013, subject to river water levels.

3. RaahuiPookeka A

RaahuiPookeka Ais Waikato RiverCare's first Waikato River Authority funded site and is situated within Huntly Township on the true right bank or eastern side of town. The Waikato Regional Council administers this land as part of the Lower Waikato Flood Protection Scheme with key stop bank infrastructure protecting Huntlylocated at this site.

This site begins at the river bank off the end of Jackson Road, next to the Waikato District Council managed water treatment plant and finishes 1081m south in line with the first house viewed when travelling into Huntly on SH1from the south.

Fencing and site preparation has already started and is planned to be completed in autumn 2013 following the removal or burning of cleared tree weeds on the site.Site planting is expected to start in August subject to river levels and ground conditions. This restoration project is one of Waikato RiverCare's biggest projects in recent years and is possible due to the excellent support of our sponsors and the Waikato River Authority.

Completed Sites

Huntly A (Huntly College)

This year Treescape completed weed maintenance at this 600m long site, focusing effort on Yellow flag Iris. Waikato RiverCare will continue to complement the Waikato Regional Councils work to eliminate Yellow Flag Iris from the lower Waikato River by continuing to monitor completed projects and taking steps to address weed threats when they are identified.

TumateMahuta Drive

This site is now a Waikato District Council managed project, with no further Waikato RiverCare involvement.

Horahora A

This is a completed project, with yearly project inspections and a pulse management approach, working with adjoining landowners.

Gedye project

Completed in 2011/12, day to day management of this site is now completed by the property owners. Waikato RiverCare will continue to maintain an interest in the site with property visits every two years.

Tuakau (Batkin Reserve)

This site has now been returned to the Waikato District Council to maintain and oversee day to day works. A site inspection in late 2012 identified Yellow Flag Iris encroachment into the planting which has now been addressed by a Council Reserves contractor.

Future Waikato RiverCare involvement at this site will be limited to site inspections and raising any identified issues with Council staff.

Review, Assessment and Evaluation of the Society's Performance

Compliance with Governing Legislation

The governance of Waikato RiverCare continues to follow the articles set out in the Society's constitution that has an Executive Committee comprising:

- Each Foundation member can appoint one representative to the Executive Committee
- Election of up to three representatives from the General Membership to the Executive Committee.

Waikato RiverCare has twelve foundation members listed for the 2012/13 Financial Year. The Foundation Members of Waikato RiverCare have renewed their commitment to the society for the 2013/14 year and continue to have an active involvement in the executive committee decisions. There has been one resignation for the upcoming year, from Derek Edwards of Naturally Native.

All subscription requirements have been fulfilled.

Compliance with the Society's Objectives

Waikato RiverCare has been compliant with the objects and rules listed in the Constitution: The Society was established for environmental and charitable objects and purposes within New Zealand only.

- a) **Core Activities** the enhancement of the natural water and riverside environment of the Lower Waikato River and thereby benefit the users of the river and its environments, local communities, and visitors now and for future generations through:
 - Providing improved plant and animal habitat in and around the Lower Waikato River for general ecological benefit,
 - Promoting public interest and appreciation of the Lower Waikato River and its environments through education and communication with local communities and other river users for the benefit of achieving awareness and support for the need to maintain and enhance the Lower Waikato River environment.
- b) **Funding** to raise, accept, accumulate and employ funds for the environmental and charitable purposes authorised by these objects.
- c) **General** to do all such things that are conducive or incidental to the attainment of the environmental and charitable purposes authorised by these objects.

Performance Measures

Waikato RiverCare measures its performance by assessing project success through site evaluations, pest and native plant monitoring, the use of photo points to monitor planting success and the number of sites moving from active management to completed, and thereafter receiving pulse maintenance. Waikato RiverCare is working with a PhD researcher to assess its monitoring systems and to look at improving this aspect of our work. Staff are given Key Performance Indicators to achieve and continual learning is core to the Waikato RiverCare ethos.

Performance in relation to the Strategic Business Plan

The objectives in the Strategic Business Plan are:

• To plant up to two hectares (two kilometres of riverbank 10 metres wide) per year.

Table 3is a summary of the infill planting undertaken during the 2012-2013 year, whilst Table 4 lists the species of plants used overall.

1. STATEMENT OF ACCOUNTING POLICIES

The financial statements presented here are for the entity Lower Waikato Enhancement Society Inc., a registered company under the Companies Act 1993.

Lower Waikato River Enhancement Society Inc. qualifies as an Exempt company under the Financial Reporting Act 1993. These financial statements have been prepared in accordance with the Financial Reporting Act 1993 and the Financial Reporting Order 1994. Further, the company has provided additional information in accordance with the framework for Differential Reporting issued by the New Zealand Institute of Chartered Accountants.

Measurement Base

The accounting principles recognized as appropriate for the measurement and reporting of earnings and financial position on accruals basis and are based on historical cost, with the exception of certain items for which specific accounting policies have been identified.

Changes in Accounting Polices

There have been no changes in accounting policies. All policies have been applied on bases consistent with those used in previous years.

(a) Goods and Services Tax

These Financial statements have been prepared on a GST exclusive basis with the exception of accounts receivable and accounts payable which are shown inclusive of GST.

(b) Taxation

No Provision for Income Tax has been made as there is no current or deferred tax payable.

(c) Investments

Share investments in listed companies are stated at their fair value. Initially they are recorded at cost, and are then values at market bid prices at the Statement of Financial Position date in subsequent periods. Any gains or losses generated as a result of revaluation is recognized in the statement of Financial Performance.

Other investments are stated at cost less any amortization. Amortisation is recognized in the Statement of Financial Performance.
